

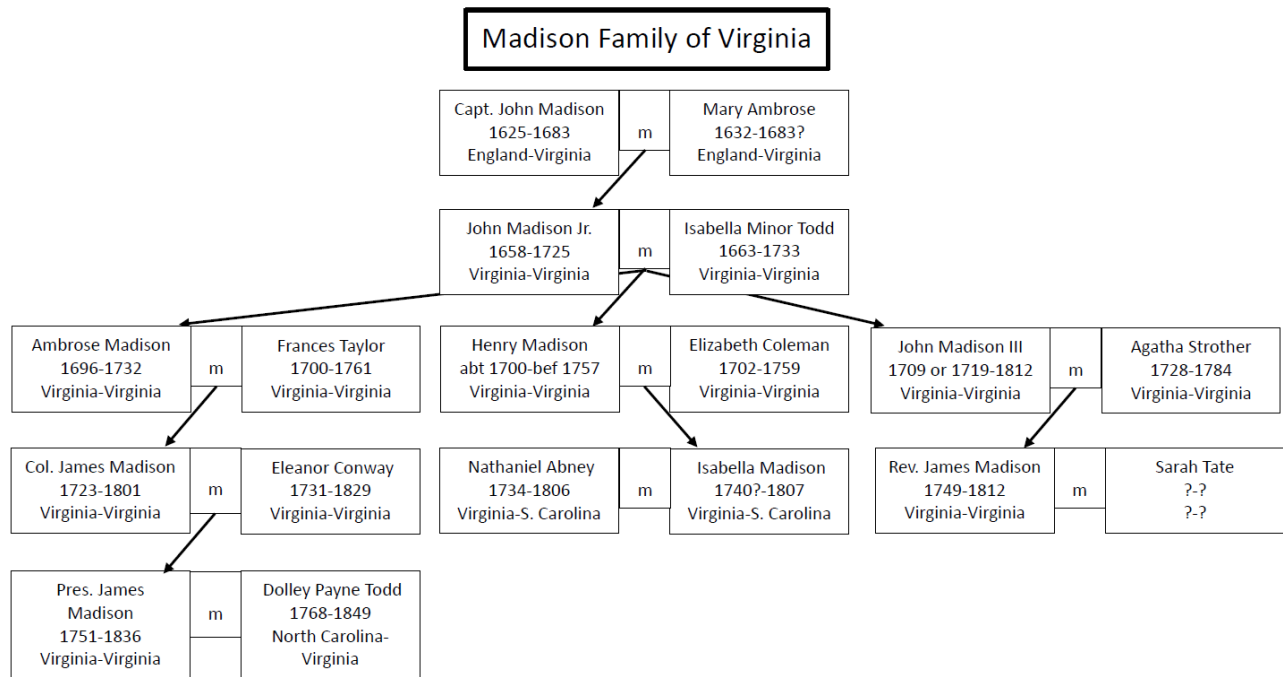
Leah Barclay (c 1723-1800), Wife of Robert Barclay (1722/23-1788)
Born ?; Died Rowan County, North Carolina
Barclay Connections - Madison and Abney Families

Many American Barclays, including myself, descend from Robert Barclay, who was born 3 March 1722/23-1788 in New Jersey and died 18 May 1788 in Rowan County, North Carolina, and his wife Leah. I have seen it reported in other people's family trees that Leah's surname was Todd, Madison, or Freeman—usually Madison or Todd Madison. Additionally, I have seen other descendants of Leah say that she was a relative of James Madison (1751-1836), fourth president of the United States of America. I had never found any DNA or documentary evidence to support any of that, though. Until... I recently have discovered that my mother has two autosomal DNA matches, one of whom (14 cM | 1 segment) descends from Isabella Madison (c 1740-1807) and Captain Nathaniel Abney (1734-1806) and the other (10 cM | 1 segment) descends from either this same couple or from Nathaniel's brother, Captain William Abney (1736-1832). Both are matches on the Barclay side of the family.

I have been able to find a good number of records regarding the Abney and Madison families, since the Abneys included American Revolutionary War officers, and the Madisons were among the American Founders. I will note that like many early genealogical records, there are some inconsistencies, but I believe I have been able to tease out some accurate information.

Using several sources, I have been able to construct a family tree for the Madison family of Virginia. It is not exhaustive but includes the main characters in our story.



Note that Isabella Madison's place in the tree is open to some debate with different sources naming different men as her father. According to an Abney family Bible included in a collection called "Abbey, Acuff, Aldredge Bibles" found on the [Family Search](#) site and attached to Nathaniel Abney, "Isabella Madison was the daughter of John Madison [Jr.] & wife Isabella [Minor] Todd Madison..." (See Appendix 1.) This cannot be correct, however, because both this John Madison and his wife Isabella Minor Todd Madison died before Isabella Madison Abney was born. The [Find a Grave memorial for Isabella Madison Abney](#) states "...it is now believed [Isabella Madison Abney] was the granddaughter of [John Madison Jr. and Isabella Minor Todd Madison] & daughter of John [Madson III]'s brother Henry Madison." The [Find a Grave memorial for John Madison II](#) includes an LDS record that says, "Henry [Madison] married Elizabeth Coleman. Bef. 8/1757 Henry died. (S) See children. 1. Isabell Madison, born 1736-1742. 8/1757, she chose Tschner Degraffenreid as her guardian. (S) Lunenburg Co., Court Order B4, P335. 2. Henry Madison Jr, born 1740-1743. 8/1757, he chose his uncle Roger Madison as his guardian. (S) Lunenburg Co., Court Order B4, P335." While this LDS record indicates that Isabella Madison was born between 1736 and 1742, the Abney family Bible names her birthdate as 17 September 1740, but I have found no other information to verify a specific birthdate. (See Appendix 1.) Note that while I have not found a reliable exhaustive list of the children of Henry Madison and Elizabeth Coleman, it appears that they had children older than Isabella and Henry Jr. who had reached the age of majority and seemed to have no need of a guardian when Henry died. A book titled *McCall-Tidwell and Allied Families* reports thoroughly on pp 182-183 regarding the life of Tscharner de Graffenreid. He was born in Williamsburg, Virginia in 1722 and died in Lunenburg County, Virginia in 1794. He and his first wife, Mary Baker, would have had seven to nine children by the time Isabella Madison Abney would have chosen him for her guardian. (See Appendix 2.) It is unclear whether Isabella went to live with the de Graffenreid family, but I think it is likely she lived for a time with Henry Madison's brother, Captain John Madison III, which may explain the confusion some sources have, naming another John Madison from the family, John Madison II, as her father. The diary of John O'Neall, found on [Family Search](#) and attached to Nathaniel Abney explains that Nathaniel "married Isabella Madison, daughter of John Madison, April 15, 1758." (See Appendix 3.) The Abney family Bible referenced above also notes that she was "half-sister of Jas. Madison, 1st native born bishop of Va." (See Appendix 1.) A book titled *Winston of Virginia and Allied Families* confirms on p 232 that John Madison II and Isabella Minor Todd had three sons—Ambrose, John III, and Henry—and that John III was the father of the Right Reverend James Madison, professor at and president of William and Mary College and the first Bishop of the Episcopal Church in Virginia. (See Appendix 4.) Bishop James Madison, president of William and Mary College until his death in 1812, is widely reported in his [biographies](#) to have been the cousin of President James Madison. An interesting item of note is that both the Abney family Bible and the diary of John O'Neall report that the wedding ceremony for Nathaniel Abney and Isabella Madison was performed the Reverend Henry. (See Appendices 1 and 3.) In these documents, the Reverend Henry is reported to be the father of American Founder, [Patrick Henry](#), famous for an address he gave at the Second Virginia Convention on March 20, 1775, with which he concluded, "I know not what course others may take; but as for me, give me liberty or give me death!" It is likely, however, that the Reverend Henry who performed the ceremony was not the father but the uncle of Patrick Henry, who shared the same name and was an Anglican minister. In fact, Founder Patrick Henry often went by the name Patrick Henry Jr.

To help us solve the mystery of Leah's identity, we need to review some facts about her and her husband, Robert. Leah likely was born around 1733-1735, since the first child of Robert and Leah, Elizabeth, was born in 1755. I cannot find specific information to verify where Elizabeth was born, but her headstone reads "Elizabeth Barkley Penny 1755 – 1822 Daughter of Robert & Leah, N.C. Pioneer, Wife of William, Mother." (See Appendix 5.) Since she is identified as a North Carolina Pioneer, that leads me to believe that she was born before or shortly after the family arrived in North Carolina. DNA and documentary evidence demonstrate that this Leah's husband, Robert Barclay, was the Robert Barclay born to Margaret Kerr Barclay in New Jersey on 3 March 1722/23, who made his way to North Carolina in the mid-1700s, and who died in Rowan County, North Carolina in 1788. We first find Robert in North Carolina records

named on a bill of sale for cows in 1759, and he purchased land that would become his “Home Plantation” in the Jersey Settlement among other New Jersey transplants in 1763. (For more information regarding Robert Barclay (1722/23-1788), please see this [paper](#).) Like other migrants from New Jersey and Pennsylvania to the Yadkin River area of North Carolina, Robert Barclay most likely traveled the Great Wagon Road, which was not a single road but a network of animal trails, footpaths, and wagon roads, to the Carolinas, taking him right through Virginia. I have not been able to find vital records placing Robert Barclay in Virginia on his journey, but I think that if Leah was indeed a Madison or Abney, they very well may have met in Virginia when he was enroute to North Carolina.

Where does Leah fit into the family tree of the Madisons of Virginia, if anywhere? It is still unclear, but autosomal DNA and documentary evidence supports that she was somehow adjacent to the Madison and Abney families. Research regarding Leah’s ancestry and immediate family is ongoing. If you descend from Robert and Leah Barclay, I have a request for you. If you have any autosomal DNA or documentary evidence that connects her to the Madison or Abney (or other) families, please share that with me at leah@clanbarclayinternational.org. IMPORTANT: Somebody else’s family tree with no supporting documentation is not helpful here. We are looking for robust evidence supported by vital records (church or government documents), old family Bibles, history books, published papers, etc.

Nathaniel, John's ancestor was born April 4, 1734. He married Isabella Madison, daughter of John Madison, April 15, 1758. The ceremony was performed by the Reverend Henry, father of Patrick Henry.

Ambrose^a Madison (died August 27, 1732), of Drysdale Parish, King and Queen, afterwards Caroline County; one of the first magistrates in Caroline County; moved to Spotsylvania County; married, August 24, 1721, Frances Taylor (died November 25, 1761), and had issue: (a) James⁴ Madison (1723-1801), married Eleanor Rose Conway; (b) Elizabeth⁴ Madison (1725-1773), married, *first*, John Willis; *second*, — Beale; (c) Frances⁴ Madison (1726), married, *first*, Tavenor Beale; *second*, Jacob Hite.,

2. John³ Madison, of Drysdale Parish, King and Queen County, had patents 1719/20, 1725/6, 1728; he is called captain in 1728 and 1734₂; magistrate in King and Queen County, 1733; he was *probably* father of (a) John⁴ Madison, of Caroline County, whose name appears in Caroline County as early as 1741/2; justice of the peace in Caroline, May, 1743-October, 1745 (the last appearance of his name in Caroline records). In March, 1744/5, John Madison and Agatha, his wife, made deeds in Caroline Court to Samuel Haws and Elijah Daniel.₁ John Madison moved from Caroline County to Augusta County, of which he was long the clerk, and which he represented in the House of Burgesses 1748-54. He was father of the Right Reverend James Madison (born at Port Republic, Augusta, now Rockingham County, August 27, 1749; died at Williamsburg, March 5, 1812), professor in and president of William and Mary College, first Bishop of the Protestant Episcopal Church in the Diocese of Virginia.

3. Henry^a Madison, of King and Queen County, who had patent in 1728; he is charged with 650 acres in King William County Quit Rent Roll in the year 1704; was living in St. John's Parish, King William County, 1734. He was *probably* the Henry Madison, of King William, who had issue: (a) Ambrose Madison, living in King William County, 1795; (b) John Madison, of King William (died
